ANKUR POLICY for MEMBER USER GROUPS

(Passed by BOT on June 29, 2005)

1. Nomenclature: "Ankur" – denotes Ankur Gujarati Samaj, Inc.

"AGB" - denotes Ankur General Body

"Ankur hall" – denotes Ankur's building located at 9502 Highland Ave., Cincinnati, Ohio 45242

"Group" – denotes a group of current Ankur members

"BOT' - denotes Board of Trustees of Ankur.

2. Classification of Groups: Groups are classified, broadly, as Group A, B, or C, as described further. All members of Group A, B, and C to be current Ankur members.

Group A: Purpose: To promote Ankur's objectives as defined in Ankur

constitution article II.

Duration of Ankur hall use: Maximum 30 weeks in a given calendar year of 52 weeks. Maximum 4 hours of use per meeting. 12 participants

minimum per meeting.

Fee: No admission fee is charged to members.

Kitchen: Kitchen facilities is not used. No lunch or dinner is served.

All activities of the Group to be approved by BOT.

Group B: Purpose: Mostly personal interest and enjoyment.

> Duration of Ankur hall use: Minimum 35 weeks in a given calendar year of 52 weeks. Limit one day per week. Maximum 4 hours of use per meeting. 12

participants minimum per meeting.

Fee: Admission fee is charged to members.

Kitchen: Kitchen facilities is not used. No lunch or dinner is served.

All activities of the Group to be approved by BOT.

Group C: Purpose: Personal interest and self-improvement.

Duration of Ankur hall use: Minimum 20 weeks in a given calendar year of 52 weeks. Limit one day per week. Maximum 4 hours of use per meeting. 12 participants minimum per meeting.

Fee: Admission fee is charged to members.

Kitchen: Kitchen facilities is not used. No lunch or dinner is served.

Instructor: Paid instructor conducts classes. Instructor fees to be paid by the Group.

All activities of the Group to be approved by BOT.

- 3. Preemption: Any program or event scheduled by Ankur that conflicts, with the activities of Group A, B, or C, shall preempt Group's activities. Reasonable notice of preemption to be given by Ankur to the concerned Group.
- 4. Equipment: Any and all supplies, equipment or furniture needed for Group A's, B's or C's activities to be supplied by the concerned Group; Ankur will not be responsible.

ANKUR POLICY for MEMBER USER GROUPS (continued)

(Passed by BOT on June 29, 2005)

- 5. Snow Removal: Group A, B, or C to remove the snow around Ankur hall on the day of their activities; Ankur will not be responsible.
- 6. Member User Fee: Ankur will charge member user fee to Group B and C for their activities in Ankur hall as follows:

Group B: \$60 per month.

Group C: \$30 per meeting.

No user fee will be charged to Group A.

- 7. Clean Up: Group A, B and C to clean up Ankur hall after their activities are finished. Cleaning charge will be assessed for hall left unclean after the Group's activities.
- 8. Non-Classified Groups: A. Groups with single event, where admission fee is charged to members, to pay member-rental charge as published in Ankur newsletter.
 - B. Other Groups to be reviewed individually by BOT.
